Sandy Sanders and Chambrel Riley-Williams were present representing the Port.

The Prayer was said and the Pledge was recited.

Agenda Item 9a(1), "An Ordinance establishing ferry toll rates and providing for discounts and exemptions thereof; establishing ferry hours of operation; adopting policies and procedures for ferry operations; and otherwise to provide with respect thereto" was offered and seconded. A discussion was held and then the item was withdrawn.

There being no matters to address under the following Agenda Item 2, "Executive Session", Commissioner Rousselle moved to Agenda Item 3, "Status Report by the Executive Port Director". Without objection, so ordered. The following topics were addressed by Sandy Sanders:

- The Port & Parish staff had a TEAMS meeting with Phillips 66 officials in regard to the possible land donation from Phillips 66 for land designated for the water booster station. A survey is being done and once it has been completed, talks regarding the property acquisition can begin;
- The Port continues to meet with DOTD to talk about the Container Terminal and the eventual moving of Hwy. 23;
- The Port met with the Port of Jacksonville to observe the LNG bunkering of vessels. Also in attendance was members from APM Terminals, Devco23, Crowley Marine Logistic and Eagle LNG. The Port reviewed general operations and safety and emergency responses, along with a demonstration of the bunkering operation utilizing LNG. The members of Port in attendance were also coached on procedures and interactions with the USCG;
- The Port spoke with Matthew Kegg from Tallgrass to see if there have been any prospects in commercialization efforts in the Plaquemines Liquid Terminal. Mr. Kegg said that there were none.
- The Port talked about levee protection and the Point Celeste Pump Station.
- The Port, along with Chris Fetters, had a meeting with some of the residents from Ironton in regard to relocation and other alternatives on Sunday, February 6, 2022;
- Lastly, the Port reported that they met with some of the Board members to discuss some specific details of the SP Project. The topics of discussion included budget, schedule and vendor database.

Mr. Chris Fetters provided a PowerPoint presentation to provide an update on the LGGT Mainline Extension and Mr. Vic LaFont provided a PowerPoint presentation on the vendor management on the Mainline Extension Project.

Commissioner Rousselle moved to Agenda Item 3a, "Financial Report/Budget to Actual". Without objection, so ordered. Chambrel Riley Williams reported:

- The Port's year to date totals are as follows: Revenue is at \$10,617,745; Expenses are \$11,162,607; which leaves the year-to-date Net Revenue of the Port at -\$544,862;
- The Port Tariff revenues are 7% above budget from 2021, and 12% from 2020;

- The Port's overall Total Revenues are 2% below budget mostly due to WRDDA (grant) Revenue;
- The Port's Personal Services are 4% below budget, and the Financial Services are 31% below budget due to year end non-cash items and 4th quarter interagency fees that were unrecorded;
- Lastly, the Port's overall total Operation Expenses are 21% below budget. This is due to being 13% under budget in Rentals/Leases, 42% under budget in Maintenance, and 31% under budget for Professional, Consulting & Technical Services and Employee Expenses.

There being no matters under Agenda Item 4, "Bids and Advertisements" and no items for introduction under Agenda Item 5, "Introduction of Ordinances and Resolutions", Council Member Rousselle moved to Agenda Item 6, "Ordinances and Resolutions on second reading and final passage". Without objection, so ordered.

ORDINANCE NO. 22-5

The following Ordinance was offered by Commissioner Rousselle who moved its adoption:

An Ordinance authorizing Sandy Sanders, Executive Director of the Plaquemines Port, Harbor and Terminal District, to purchase land owned by Brian and Vanessa Fisher (the Fishers); and otherwise to provide with respect thereto.

WHEREAS, through negotiations with the Fishers, a recommendation is being made to approve the acquisition of property owned by the Fishers, contiguous to property currently owned by Plaquemines Port, Harbor and Terminal District; and

WHEREAS, the property has been appraised, and the fair market value has been calculated to be \$ 392,000; and

WHEREAS, the negotiations between the Fishers and the Port recognize a total purchase price of said property for \$ 392,000 (three hundred ninety-two thousand) for Lot 8, Pointe Celeste Farms S/D, currently owned by Brian and Vanessa Fisher;

NOW, THEREFORE:

BE IT ORDAINED BY THE PLAQUEMINES PARISH COUNCIL AS THE SOLE GOVERNING AUTHORITY OF THE PLAQUEMINES PORT, HARBOR AND TERMINAL DISTRICT THAT:

SECTION 1

It hereby authorizes and directs Maynard Sanders, Executive Director of the Plaquemines Port, Harbor and Terminal District, to acquire the land owned by Brian and Vanessa Fisher, more fully described by the legal description attached hereto as Exhibit "A."

SECTION 2

The acquisition shall be for a purchase price of \$ 392,000 (three-hundred ninety-two thousand dollars) plus closing cost for the transfer of ownership of the land at Lot 8 Pointe Celeste Farms S/D, currently owned by Brian and Vanessa Fisher, to the Plaquemines Port, Harbor and Terminal District.

The Secretary of this Council is hereby authorized and directed to immediately certify and release this Ordinance and that Port employees and officials are authorized to carry out the purposes of this Ordinance, both without further reading and approval by the Plaquemines Parish Council.

WHEREAS, the Plaquemines Parish Council ("Council") as the sole governing authority of the Plaquemines Port, Harbor and Terminal District (the "Port), is authorized to establish the policy of the Plaquemines Port, Harbor and Terminal District; and

WHEREAS, the Executive Director of the Port is obligated to abide by and enforce the policies adopted by the Council; and

WHEREAS, contracts that bind the Port to make payments in the future may be deemed to create public debt, initiating approval by the State Bond Commission, unless such contracts contain appropriate language in regard to termination for convenience and/or termination for non-appropriation; and

WHEREAS, to avoid potential conflicts in the interpretation of contracts, the Council deems it necessary to establish a policy directing the inclusion in all Port contracts of certain language to clarify, for all parties thereto, how those contracts are to be interpreted; and

WHEREAS, in order for the Council Secretary's Office to maintain accurate records, it is necessary to create a policy wherein copies of signed contracts shall be emailed to the Council Secretary withing two weeks from the date of execution;

NOW, THEREFORE:

BE IT ORDAINED BY THE PLAQUEMINES PARISH COUNCIL AS THE SOLE GOVERNING AUTHORITY OF THE PLAQUEMINES PORT, HARBOR AND TERMINAL DISTRICT ("PORT") THAT:

SECTION 1

It shall be the policy of the Port that all contracts for professional or other services that are for a term of one year or less and which are paid monthly shall include the following language:

- The compensation paid shall be due in the month following the month after the services are rendered, upon the submission of an invoice from the Contractor to the Port.
- This contract may be terminated, with or without cause, by the Port, by action of the Council, upon at least 30 days written notice to the Contractor, which notice may be by email, facsimile or other means. In the event the termination takes effect during a month, the monthly compensation shall be pro-rated.

SECTION 2

It shall be the policy of the Port that all contracts for professional or other services that are for a term that extends beyond a single fiscal year shall include the following language:

- This contract is not intended to create public debt of which the Port is the obligor.
- This contract may be terminated, with or without cause, by the Council, and upon at least 30 days written notice to the Contractor, which notice may be by email, facsimile or other means, except as otherwise provided for herein. The compensation provided for herein that would have been due within the fiscal year in which the contract was terminated shall be pro-rated based upon the number of days into the fiscal year as of the effective date of the termination.
- The adoption of the Operating Budget of the Port that fails to appropriate funding available for the contract or the explicit exclusion of the contract from the Budget shall effect a termination of the contract without the requirement the written notice otherwise required for the termination of the contract. The contract will terminate on at the end of the last day of the fiscal year for which funding was Budgeted, except as otherwise provided herein.
- The adoption of an amendment to the Operating Budget of the Port that removes the funding available for the Contract or provides for the explicit exclusion of the contract from the Budget, shall effect a termination of the contract without the requirement the written notice otherwise required for the termination of the contract. The contract will terminate upon the effective date of the amendment. The compensation provided for herein that would have been due within the fiscal year in which the contract was terminated shall be pro-rated based upon the number of days into the fiscal year as of the effective date of the termination.

SECTION 3

It shall be the policy of the Port that all signed contracts are sent to the Council Secretary's Office within two weeks of execution.

SECTION 4

The Secretary of this Council is hereby authorized and directed to immediately certify and release this Ordinance and that Parish employees and officials are authorized to carry out the purposes of this Ordinance, both without further reading and approval by the Plaquemines Parish Council.
