WHEREAS, The Plaquemines Board consents to transferring the 11-Mile Rail Extension tasking under the existing Professional Services Agreement with Infinity Engineering solely under a Task Order with a \$1.2 Million change order cost per Infinity's Proposal dated June 18, 2024; and

WHEREAS, the completion of the Projects Intellectual Property must occur by the end of 2025 to fulfill the CPRA Diversion Rail Bridge funding requirements and deadlines; and

WHEREAS, amending the Plaquemines Port, Harbor, and Terminal District 2024 Five-Year Capital Improvements Plan by appropriating \$1,200,000 to the 11 Mile Rail-CAD/Surveys Project is requested;

#### NOW, THEREFORE:

BE IT ORDAINED BY THE PLAQUEMINES PARISH COUNCIL AS THE SOLE GOVERNING AUTHORITY OF THE PLAQUEMINES PORT, HARBOR AND TERMINAL DISTRICT THAT:

### SECTION 1

Plaquemines Parish Council as the sole governing authority of the Plaquemines Port, Harbor & Terminal District (the Port) hereby authorizes Charles D. Tillotson to issue Task Order No. 6 to Infinity Engineering to recreate the computer aided drawings, recreate needed surveys, and start the Surface Transportation Board process for the 11 Mile Rail Extension project.

## **SECTION 2**

The Five-Year Capital Improvements plan is amended by appropriating \$1,200,000 to the 11 Mile Rail-CAD/Surveys Project from the Plaquemines Port, Harbor and Terminal District, Unrestricted Fund Balance; funding year 2024.

## **SECTION 3**

The Secretary of this Council is hereby authorized and directed to immediately certify and release this Ordinance and that Port officials and employees are authorized to carry out the purposes of this Ordinance, both without further reading and approval by the Plaquemines Parish Council.
